During the winter storm last month, our PID crews continued to work to keep Downtown clean and safe. The streetscape team deployed thousands of pounds of de-icer to help clear sidewalks, and the Ambassadors were busy assisting motorists with tire repair, stuck cars and dead batteries while also escorting and assisting pedestrians in navigating slippery sidewalks.

Street and curb sweeping resumed immediately after the snow and ice melted away. PID contractors worked to remove the sand used on city streets during the storm. This sand was removed as quickly as possible to reduce dust.

DFWI TO HOST MAYORAL AND DISTRICT 9 CANDIDATE FORUMS

Join Downtown Fort Worth, Inc. and the Fort Worth Downtown Neighborhood Alliance in Burnett Park for two candidate forums ahead of the General Election for Fort Worth Mayor and City Council.

CANDIDATE FORUM DATES

Thursday, April 1 | 5-7pm Mayoral Thursday, April 8 | 5-7pm District 9

The format will be the same for both forums. Each candidate will have the opportunity to introduce themselves and make a two-minute opening statement. Following this, a moderator will ask questions. Each candidate will have up to one minute for response. Attending citizens may submit questions prior to the beginning of the forum, or send questions in advance to Beckyf@dfwi.org.

All Mayoral and Council candidates have been sent a DFWI Annual Report and a State of Downtown publication so that they are aware of the underlying dynamics of Downtown. While these are pre-COVID publications, they still illustrate the long term trajectory of Downtown and redevelopment efforts.

HERITAGE PARK UPDATE

The DFWI Board authorized the execution of a design contract for the final phase of the Heritage and Paddock Parks and courthouse area streetscape improvements. This project has evolved over the years from a simple "reopening" of Heritage Park to addressing a



number of issues that "disconnect" the northern part of Downtown from both the river and the rest of Downtown. Curing these issues will create new amenities for Fort Worth that give pedestrians much more meaningful city and river experiences. The final stage of design is funded 50-50 through private donations and city bond funds dedicated to Heritage Park. The lead design firm for Heritage Park is MIG, with local partners Huitt Zollars and Emraes. The lead design team for Heritage Plaza is Bennett Benner Partners.

CITY OF FORT WORTH CLOSES ON NEW CITY HALL BUILDING

The city closed on the purchase of the former Pier 1 Imports headquarters building, at 100 Energy Way on January 27, 2021. The purchase price was \$69.5 million, and renovations will bring the total estimated project budget to \$100 million. Renovations will include constructing new public meeting spaces and reconfiguring offices.

An interdepartmental steering team of city employees will guide visioning, programming and transition for the new City Hall, current City Hall and several other city-owned and leased buildings in Downtown and Near Southside. Move-in is expected to begin in 2022.

FORT WORTH HOUSING SOLUTIONS ACQUIRES **NEW DOWNTOWN HEADQUARTERS**

Fort Worth Housing Solutions (FWHS), the city's primary provider of rental assistance and affordable housing communities, is moving its headquarters to 1407 Texas St. in Downtown.

412-unit community opened in 1940 and was closed as part of FWHS strategy to deconcentrate poverty and allow residents to use rental assistance at homes of their choice across the city.

"The 2020 closing of Butler was a milestone for our city – it gave families the opportunity to relocate to neighborhoods with better access to jobs, transportation, quality schools and services, such as grocery stores," FWHS President Mary-Margaret Lemons said. "This shift allowed our agency to move to a headquarters with better access for the people we serve and the modern amenities and technology we need to support them."

2021 MAIN STREET FORT WORTH ARTS FESTIVAL CANCELED



The Board of Directors of Downtown Fort Worth Initiatives, Inc. (DFWII), producers of the MAIN ST. Fort Worth Arts Festival (MAIN ST.) have announced the cancellation of the 2021 festival. Due to ongoing Coronavirus (COVID-19) concerns and restrictions on large gatherings, the annual festival initially scheduled to

occur April 15-18, 2021, will not take place this year.

We encourage everyone to visit the online gallery, browse through participating artists and support artists and entertainers who have been severely impacted by nationwide festival cancellations. We especially encourage you to check out MAIN ST. artists from around the Metroplex and aspring artists who started their exhibition journeys with us as Fort Worth Emerging Artists.

MAIN ST. will relaunch April 7 – 10, 2022. Final plans will be released later this year with overriding consideration given to public health and safety.
